Seminar Title: Community-Police Relations: Basic Approaches and Positive Outcomes

## Presenters' Biographies



Executive Director Frank Demes oversees Case Western Reserve University's (CWRU) police and security operations, and the communications emergency management and facilities security. Demes joined CWRU after having served as the Assistant Chief of Police and Interim Chief of Police at The George Washington University, Washington, DC. He is instrumental in developing new approaches to safety, including the Bike Patrol, Student Emergency Medical Services, community policing, and crime prevention programs. He is a graduate of the Military Police Academy, Fort McClellan, Alabama.



Interim Chief Jay H. Hodge has been influential in developing campus safety talks, and facilitating a vision of service and treamwork that best supports the University commuity. He faciltates and participates in dialogue about safety and policing at CWRU. For more than eleven years, he has been employed in the University's police department, and has assumed a variety of leadership positions and responsibilities. He is a graduate of the Ohio State Highway Police Academy and the University of Akron, Ohio.
