- 1. Motion: The Staff Advisory Council recommends that the university athletic center policy regarding children be expanded to allow dependent minors to accompany eligible parents or guardians to be admitted to the facilities for free at all times the facilities are open to staff. The current policy allows for free admission of accompanied dependent minors on one specific day a week. However, removing the current restriction would allow staff more opportunities to engage in family activities in a manner that accommodates individual schedules.
