Studied ritual interactions through participant observation. Focused on the cultural construction and experience of violence. Used semi-structured interviews to investigate relationships and beliefs about power and sexuality. Employed grounded theory analysis to analyze texts.

In Dangriga, Belize, explored how globalizing forces, especially the compression of time and space through advancing technologies, such as media and tourism, influence how women construct gendered identities. Employed participant observation, interviewing, and focus groups to solicit information regarding beauty practices and economic strategies.
