#### **COURSE OVERVIEW**

- This course is designed to reinforce and build upon the material and fundamentals addressed in applied lessons, as well as offer rehearsal techniques and performing experience in chamber music pedagogy.
- This course adheres to the policies in the 2023-24 catalog and Student Handbook
- Additional performing opportunities occur throughout the academic year, both on and off campus.
- An open forum to discuss aspects of all chamber music related topics by the student as a group is encouraged in both your applied rehearsals and coaching.
- A weekly rehearsal time to be arranged by the students is to be strictly adhered to for progress of the ensemble.

# **CHAMBER MUSIC GROUPS AND ENSEMBLES**

- Students are exposed to chamber music and ensemble skills, addressing all aspects of musical interaction needed for quality chamber music studies at performance level.
- Both musical, technical, and diverse repertoire will be rehearsed, prepared, and performed.
- All students will be assigned to a chamber group during the first week of classes, at the beginning of each semester and /or academic year.
- Each group receives ensemble coaching during the arranged weekly coaching time. It is expected to be prompt to both coaching and student run rehearsals.

# **REQUIRED MATERIALS:**

- Assigned materials will be distributed by your instructor as well as acquired from our Music Library.
- Please maintain the repertoire you are in possession of, so it is not become damaged and/or lost.
- Students are strongly encouraged to engage is the selection of repertoire based on your musical interests, group conversations and past performing experiences with other chamber groups.

# **GOALS AND OBJECTIVES:**

- A minimum of three to four performances each semester shall take place.
- Additional performances occur throughout the academic year at such world class local institutions such as the Cleveland Historical Society, The Cleveland Museum of Art, The Cleveland Botanical Gardens the Cleveland Clinic, Judson Manor, and others.
- Additional rehearsals and preparation are required for off campus events and performances.
- Coaching sessions are not for practicing or learning your individual parts, but for receiving input on music that has already been prepared.
- Direct input and selection of repertoire for each chamber group by the students is essential.

#### PARTICIPATION:

Students are strongly encouraged to always maintain the lines of communication open with the instructor, addressing any topic-be it effective practice strategies, clarification of materials addressed within a coaching, any area of concern related to progress, teacher's expectations, etc. Student initiative in the choice of repertoire is encouraged.

#### **COMMUNICATION:**

Students are required to check their email for communication relevant to this course. Direct email communication with to assist you in any way is always encouraged throughout the academic year.

#### **GRADING:**

- A. No more than one unexcused absence. Consistent preparation of weekly assigned material. Excellent performances for recitals and off-campus performances.
- B. Two unexcused absences. Well-prepared for most weekly assignments. Very good performances for recitals and off-campus performances.
- C. Three unexcused absences. Well-prepared for half of the weekly assignments. Acceptable performances and off-campus performances.
- D. Four unexcused absences. Well-prepared for less than half the weekly assignments. Borderline performances and off-campus performances.
- E. Five or more unexcused absences. Unacceptable preparation of weekly assignments. Unacceptable performances and off-campus performances.
