#### 31st: NIH and NSF Changes to Proposal Documents 10 – 11 am

Federal agencies have recently updated their guidelines for how to complete proposal forms. Join us to learn how they have changed.

This course reviews the fundamental issues of research administration, including basic issues associated with managing an award, roles, and responsibilities of staff, and governing cost principles.

#### 12th: The Ins and Outs of Swapping Research Reagents, 1-2 pm

Sharing reagents is a common occurrence in academic research. Learn what a material transfer agreement (MTA) is and what to do if you receive one, or how to proceed if you want to send materials out of the university.

#### 18th: Sponsored Projects: Proposal to Award 2 – 3:30 pm (CAPS Credit)

This course reviews the basic processes involved with SpeedType setup in the Office of Sponsored Projects Administration, including an overview of eURF procedures, proposal submission, award documentation and subcontract agreements.

#### 19th: Sparta IRB: Getting Started, 2-3 pm, 3 credits

This session will introduce CWRU IRB investigators to the Sparta IRB system. Investigators, administrators, and students who will submit IRB applications are encouraged to attend.
