## **COURSES**

### **LLEAP 3-Transactions (2018 – Present)**

Design and teach LLEAP (Legal Writing, Leadership, Experiential Learning, Advocacy, and Professionalism) 3-Transactions, a three-credit course for second-year students. LLEAP 3-Transactions is an advanced writing and skills course that exposes students to different types of contract writing. In LLEAP 3-Transactions, students are immersed in a transaction from start to finish. Students perform legal research, attend client meetings, conduct due diligence, and negotiate deal-specific issues - all culminating in the creation of the documents necessary to “close the deal” that is contemplated in their asset purchase agreement.

During the course, students write and revise numerous contract provisions. They write a letter of intent or non-disclosure agreement and advisory correspondence to clients based on the results of their legal research. They create and implement a due diligence plan, write letters to and respond to letters from opposing counsel, write an amendment to an asset purchase agreement, create and implement a closing strategy, and prepare all necessary closing documents. Students in LLEAP 3-Transactions are also asked to analyze financial statements to evaluate business assumptions underlying the proposed transaction, and they record their “billable” time for certain tasks.

### **Bankruptcy (2020 – 2023; 2025 – Present)**

Co-teach a three-credit course for second-year and third-year students. This course examines the federal bankruptcy process for individuals, businesses, and municipalities. Students learn the basics of Chapter 7, Chapter 9, Chapter 11, and Chapter 13 bankruptcies. Students in Bankruptcy are introduced to the U.S. Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, various federal and state laws and rules, and relevant cases and authority.

### **Summer Legal Writing (2022)**

Designed and taught an introduction to legal writing course giving students an opportunity to review and practice basic writing concepts and skills in a variety of legal writing assignments.

**LLEAP 3-Transactions; CORE III (2004 – 2018)**

Taught LLEAP 3-Transactions and Core III in the LLEAP and CaseArc programs, respectively. Each course focused on business negotiations and contract writing. Each also contained an experiential component in which students learned basic skills through performance simulations.
