Middle Egypt today can be identified as the part of the Nile Valley that, while geographically part of Upper Egypt (the southern part), is culturally closer to Lower Egypt (the northern part). This luxury cruise on the *M/S Darakum* will begin in Cairo stopping along the important sites of the Middle Kingdom eventually ending in Aswan. Spanning 7,000 years of history, guests will experience the heartbeat of this desert region delving deep into the history of the ancient Egyptian kingdoms and various dynasties. Her photographic work has been featured on National Geographic, NBC, CNN and LiveScience. Meghan currently serves as an Assistant Director at Nuri, Sudan, an expansive cemetery used by the rulers of the ancient kingdom of Kush.

Explore Cairo, including medieval quarters, the Great Pyramid and the Sphinx, the Egyptian Museum of Antiquities, and the Citadel.


In Fayoum, view the Hawar and Maydom pyramids that outdate the famous pyramids of Giza.

In Luxor, view Karnak Temple—one of the largest religious buildings in the world.

Learn about the engineering feat to build the Aswan High Dam.

View the temples of Abu Simbel, which were relocated after building the High Dam in the early 1960s.

PROGRAM ITINERARY

May 10, 2023 – Depart U.S.

May 11 – Arrival Cairo

Met on arrival and transferred to the MS Darakum river cruise. Complete all embarkation protocols and settle into your cabin. Trip briefing by your tour manager/ guide.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 12 – Sightseeing in Cairo

Disembark and visit the famous Grand Egyptian Museum where there are tens of thousands of items on display. You will also have free access to the museum's Treasures Room where you can see all the beautiful artifacts that were recovered from the tomb of King Tutankhamen when it was excavated in 1922.

Brief stop for lunch.

Next, you will be taken to see Egypt's most iconic ancient monuments, the Great Pyramids of Giza and the Sphinx. Return to the ship in the late afternoon.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 13 – Sightseeing in Medieval Cairo & Citadel

Morning visit of the Citadel and Mohamed Ali followed by visits to Sultan Hassan and Ibn Touloun Mosques.

Brief stop for lunch.

Afternoon Visit to Khan el Khalili and walking tour. This is the medieval part of Cairo and a historic center of this ancient city. The Khan el-Khalili today is occupied by local merchants and traders, and one of the most popular *souqs* (bazaar) in the region.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 14 – Cairo to Fayoum (excursion by road). Re-embark at Beni Suef

Disembark and depart by coach to Fayoum. This the most significant center of the cult of Sobek, the crocodile-god, a protective deity who was believed to protect against the dangers of the Nile. View the ancient Hawara and Maydom Pyramids, which outdate the famous Pyramids of Giza. Meet the cruise ship in the evening in Beni Seuf around 6:00pm.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 15 – Beni Seuf to Minya

Full day sailing to Minya. Travel past palm tree lined communities that dot the banks.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 16 – Minya

A full day of sightseeing begins with a visit to Beni Hasan to visit the fascinating rock-cut Middle Kingdom tombs of Baqet, Khety, Amenemhet and Khnumhotep II. Afternoon visit to Tuna El Gebel, the necropolis of the ancient Greco-Roman city of Hermopolis, and el-Ashmunein, the site of the ancient city itself.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 17 – Minya to Assyut

The day begins with a visit to Tel el-Amarna (formerly known as Achetaton), the northern tombs of Ahmose, Meryre, Pentu, Panehesy and the Royal Tomb of Akhenaten. Continue your tour with the Great Palace of King Akhenaten and the Small and Great temples of Aten. As the ship cruises south, it will stop in front of the Prince Tawdrous Monastery, allowing you to get a glimpse from the deck. Continue to Assyut.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 18 – Assyut to Sohag

The day will be spent sailing to Sohag.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 19 – Sohag to Naga Hamadi

This morning travel to El Balyana, where you'll visit the Abydos Temple. Return to the ship and set sail towards Luxor via the via Abu Homar's Lock. Arrive at Naga Hammadi.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 20 – Naga Hamadi to Luxor

Sail to Qena for a visit to the Dendara Temple. Discover the beautifully-preserved temples which were constructed during the 4th century BC. Continue on to Luxor.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 21 – Luxor

There's a full day visit to the archaeological paradise that is the West Bank of Luxor today. Home to the spectacular Valley of the Kings, the area offers a wealth of ancient treasures with Pharaohs' tombs dating back between the 16th and 11th Century BC. The visit also includes a visit of King Tut's tomb and the magnificent Mortuary Temple of Queen Hatshepsut (Deir el-Bahri) that sits within the valley.

Evening visit to Luxor Museum.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 22 – Luxor to Edfu

This morning the focus is on the treasures of the East Bank of the Nile. Here you can see the magnificent temples of Karnak and Luxor, which were built in honor of the Egyptian sun god Amun Ra. Take a walk through the majestic hypostyle hall with its magnificently painted pillars and gaze at the collective work of 13 centuries of successive pharaohs.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 23 – Edfu to Aswan

Today includes a visit to the incredible Kom Ombo temple. This double temple is perfectly symmetrical and was built during the Ptolemaic dynasty (4th-1st Century BC). The two temples are dedicated to the Egyptian gods of Sobek, the crocodile god, and Horus, the falcon god. Cruise towards Aswan.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 24 – Daytrip to Abu Simbel

Morning flight to Abu Simbel. Abu Simbel is a village in the Egyptian part of Nubia, about 240 km southwest of Aswan and near the border with Sudan. It is best known as the site of the Abu Simbel temples, which were built by King Ramses II and are now in the UNESCO World Heritage Site.

Return back to Aswan and visit the Nubian Museum.

Overnight: Onboard the M/S Darakum – Standard Cabin (B, L, D)

May 25 – Aswan- Cairo (flight)

Disembark after breakfast and visit the Philae Temple complex followed by a stop at the Aswan High Dam. The dam is significant for Egypt as it provides much of the water for irrigation, flood control and hydro-electric power for the nation.


Fly to Cairo and check into the hotel.

Farewell dinner at the hotel.

May 26 – Departure

Airport transfers for departure flights home or onward to your Jordan extension (see details on the next page). (B)



The terms "client" "you" and "your" refer to each person who purchases and/or uses a tour package provided by Immersion Journeys

RESERVATIONS AND PAYMENTS: A prepayment deposit \$1,000 along with a completed and signed Tour Reservation Form, proof of COVID-19 vaccination and copy of passport are required in order to confirm your reservation. Upon receipt of these forms and your deposit, we will confirm your trip. This Agreement. The signed Reservation form and the signed Credit Card Authorization section of the Tour Reservation Form are all part of your agreement with us.

The balance of your Tour cost is due of 90 days prior to departure.

TRAVEL INSURANCE: Travel insurance is **mandatory**. In the event that you must cancel your participation in a travel Tour, trip cancellation insurance may be the only source of reimbursement. Trip cancellation insurance is available for comprehensive coverage of such expenses in conjunction with cancellation due to illness or accident, and damaged or lost luggage. CANCELLATION AND REFUND POLICY: Our cancellation charges are based on the stringent payment policies of our suppliers of local services and therefore represent a reasonable estimate of our loss. Cancellation charges are expressed as a percentage of your total trip cost (excluding commercial airfare) and also depend on the day you cancel and the day of your scheduled departure from your home. Our cancellation charges are in addition to whatever the airline may charge you:



INDEMNIFICATION: You shall indemnify, defend and hold harmless Immersion Journeys, Engaging Journeys, Case Western Reserve University and its officers, employees, directors, suppliers and agents, in their individual capacities or otherwise, from and against any Losses arising out of: (i) your negligence; (ii) your failure to comply with applicable law; or (iii) your failure to comply with these terms conditions.

PHYSICAL ACCESSIBILITY: All Tours require physical independence and mobility. Any physical or mental condition that may require special medical attention or physical assistance (for example, the need for a wheelchair) must be reported in writing when you make your reservation. Participants must be able to embark or disembark vans or motor coaches alone or with minimal assistance from your traveling companion and climb stairs and step over raised thresholds without assistance. Participants requiring assistance must travel with a companion who will be responsible for handling equipment. Please understand that the Americans with Disabilities Act does not apply outside the United States.

CONDUCT DURING TOUR: You are also responsible for respecting the authority and following the directions of the tour guide and the laws of the countries in your itinerary. This includes following local government health laws requiring the proper use of face masks and following proper sanitization protocols. We may exclude you from participating in all or any part of the tour if, in our sole discretion, your condition or behavior renders you unfit for the tour or unfit for continuation once the tour has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of tour services, or may constitute a hazard or embarrassment. In such case, our liability shall be strictly limited to refund of the recoverable cost of any unused portion of the tour. Should you decide not to participate in certain parts of the tour or use certain goods included in the tour, no refunds will be made for those unused parts of the tour or goods. .



MEDICAL PROXY: If you are unable to authorize your own medical attention and treatment, you authorize Immersion Journeys or its subcontractors or agents to authorize medical attention and treatment on your behalf. You agree to hold harmless and release Immersion Journeys from any liability for medical attention arranged or not arranged on your behalf. Immersion Journeys assumes no liability regarding provision of medical care or evacuation services.

CHANGES: Changes in this Agreement may be made only in writing, signed by an officer of Immersion Journeys.

BINDING ARBITRATION: Any dispute concerning, relating or referring to this Agreement, the brochure or any other literature concerning the Tour, or the Tour itself, shall be resolved exclusively by binding arbitration pursuant to the Federal Arbitration Act, 9 U.S.C. Sections 1-16, either according to the then existing Commercial Rules of the American Arbitration Association (AAA) or pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will be governed by substantive (but not procedural) State of New York law and will take place in New York City, New York. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. Please understand that by agreeing to these terms and conditions, the participant and Immersion Journeys are waiving the right to a trial by jury. Any arbitration commenced against Immersion Journeys must be on behalf of only the signatory to this Agreement and his or her immediate family members who travelled with signatory, such as a spouse or child. Under no circumstances can participant be part of a class or other joint action.

By signing the Tour Registration form, you agree to the terms of this Terms and Conditions, Release of Liability, Assumption of Risk and Binding Arbitration Agreement. If your party includes a person under 18, then you represent that you are that person's parent or legal guardian.
