## **Learning Objectives**

#### **2021 Education Retreat Overall Objectives:**

- 1. Recognize microaggressions in the classroom and clinical learning spaces.
- 2. Identify at least three strategies to manage microaggressions when they are recognized in the learning environment.
- 3. List examples of bias in curricular materials.
- 4. Develop an inclusive approach to mentoring individuals in underrepresented groups.

#### Plenary: Keeping our Pledge to Health Equity and Anti-Racism

- 1. Demonstrate the leadership and infrastructure necessary for successful Diversity Equity and Inclusion initiatives.
- 2. Recommend system level changes promoting health equity.
- 3. Reveal the necessary structural competency training for trainees and faculty.
- 4. Recommend accountable bias reporting mechanisms.

#### Workshop 1: Enhancing Psychological Safety to Prevent Learner Mistreatment

- 1. Role-play to illustrate an example of mistreatment in the learning environment.
- 2. Define the necessary components and benefits of a psychologically safe learning environment.
- 3. Identify barriers in creating a psychologically safe learning environment and develop strategies to overcome these barriers.
- 4. Review established tools to measure psychological safety.

#### Workshop 2: LGBTQ+ Curricular Needs Assessment: Models, Processes, Reflections

- 1. Utilize ACGME competencies to conduct curricular needs assessments for expanding diversity & inclusion topics within medical education.
- 2. Compare and contrast the processes undertaken by the CWRU SOM and CCLCM workgroups on LGBTQ+ curricular integration.
- 3. Describe how students join faculty in their shared passion for LGBTQ+ healthcare to affect institutional change.
- 4. Modify an LGBTQ+ curricular inclusion intervention for expansion to other critical topics in medical education.

Workshop 3: Curriculum Review: Value of what we teach, value of the hidden curriculum in training the next generation of physicians on anti-racism

- 1. Identify ways in which the different aspects of the curriculum (both visible and hidden) can be reviewed for areas of improvement towards a culture of anti-racism.
- 2. Discuss the nuances of incorporating demographic information such as race, ethnicity, and sexual orientation in clinical cases.
- 3. Highlight ways in which the work of these action groups comes together to create a cohesive medical education in health disparities and culture shift.
- 4. Identify strategies to continually review these changes as the dialogue on race broadens to other marginalized populations.

#### Workshop 4: Approach to Microaggressions in Clinical Medicine

- 1. Define "microaggression" and its subtypes.
- 2. Review controversies surrounding microaggressions, examples and impact.
- 3. Demonstrate approaches to microaggressions from the perspectives of a victim and a bystander.

#### Workshop 5: Excellence Through Equity and Inclusion Along the Pipeline: Sustaining the Momentum

- 1. Recognize barriers along the pipeline to and through careers in medicine for underrepresented in medicine (URiM) students, trainees and faculty
- 2. Identify current efforts, as well as areas in need of development, as it relates to recruiting, supporting, and retaining URiM students and trainees
- 3. Create action items to build departmental and institutional culture that ensures an active and sustained commitment to equity and inclusion

#### Workshop 6: MedEd and its Muslim Trainees: Bridging the Gap in Professional and Spiritual Values

- 1. Gain familiarity with Islamic values pertaining to fasting, prayer, dietary restrictions, hijab and attire; recognize how these come into play as Muslims navigate the healthcare field.
- 2. Identify systematic areas for improvement that can lead to a more inclusive environment for Muslim trainees.
- 3. Recognize the myth of the Muslim monolith and acquire strategies for practicing cultural humility when it comes to working with and caring for Muslim communities.
