**MEMBERSHIP:** The COS is a standing committee of at least nine voting members, including a chairperson who is appointed in accordance with the bylaws of the Faculty of Medicine. Nine members will be elected by the Faculty of Medicine from among its membership; the dean of the School of Medicine will have the prerogative of appointing up to four additional voting members if deemed advisable. At least four members will be from the preclinical departments and at least five from the clinical departments. In addition, a dean's designate will serve ex officio with vote. The following will serve as ex officio members without vote: the deans of student affairs; the chair of the Committee on Medical Education, the vice dean for medical education; the associate dean of curriculum, the assistant dean for basic science, the assistant dean for clinical education, and the chair of the MSPRC or his/her designee; and the registrar of the School of Medicine who will serve as secretary. The COS may invite others to its meetings. The term of office of the elected members is five years. Elections will be staggered so that at least one member will be replaced or re-elected each year. An elected member resigning during a term of office shall be replaced by appointment made by the chair of the Faculty Council; an appointed member resigning during a term of office shall be replaced by appointment made by the dean or the dean's designee.
