Funding Your Future

Traditional Pathway:

When applying to the program, you can submit an application for a Student Assistantship. These positions are both need- and merit-based and offer recipients partial tuition waivers of up to \$12,000. As a student assistant in the Department of Bioethics, you could take on roles in:

- Statement of Purpose
- 2 Letters of Recommendation
- Test scores are optional: MCAT, GRE.
- International applicants must submit English proficiency scores. The accepted exams and minimum scores are:
 - TOEFL (100) or IELTS (7.0)
- \$50 application fee

Final application deadline: August 1
