Coldiron Senior Nurse Executive Fellowship Application

Fellowship Program Goal: To enhance and expand the development of senior executive nurse leaders.

Program eligibility: This Fellowship Program is open to senior nurse executives with at least five years of experience at the most senior nurse executive position in health services, public health and community-based organizations or systems, academic institutions, and professional, governmental and policy organizations within the United States.

Program Cost: \$20,000/participant; \$5,000 Coldiron scholarship will be awarded to all Fellows.

Cost to Fellow: \$15,000 plus travel costs of approximately \$4,000 for attendance at the mandatory 4 face-to-face sessions. To secure a space in the Coldiron Program, a down payment of \$5,000 is required by January 15, 2022
