Staff Advisory Council General Council Meeting Minutes

Friday, October 7, 2022 @ 10:00am - 11:30am in the Toepfer Room and via Zoom

<u>Welcome</u> at 10:05 am by Dawn Ellis. This is the first hybrid meeting of the Council since COVID, with members attending in the Toepfer Room and joining via Zoom. Many people expressed gratitude for the ability to participate via Zoom.

Speakers

- Eddie Bolton, Director of Institutional Research
 - o Engagement Survey Update
 - Gave detailed information regarding the composition of the committee and their process, the data gained through the survey and next steps. There was only a 55% response rate, lower than what Gallup had expected. They think it is because of the timing. Managers received data from the survey and schools are utilizing different strategies for responding to the data. The committee thinks one good outcome is that discussions are starting to take place between managers and employees. There will be a pulse survey checkup in November to determine the progress. Bolden took questions from the group including how to measure those who didn't participate, how to deal with survey questions that were open to interpretation and figuring out why staff is disinclined to give feedback in general.  - o Reproductive Health Task Force Update

The task force has three working groups: Reproductive Health Services Access, Academic Freedom, and Retention and Recruitment.

- Ensuring reproductive health services
 - through insurance (added travel and lodging benefit)
 and a student health emergency fund that helps fill the
 gap between cost and insurance coverage for all health
 emergencies
 - Offering free reproductive health kits for students that contain Plan B, condoms, pregnancy tests, and more as well as adding wellness vending machines that are available 24/7 and offer cough drops, ibuprofen, pregnancy tests and other items.

- 3. Providing accurate and up-to-date information on the task force website and in informational cards.
- Partnering with the faculty for campus discussions
 - 1. Reproductive health discussion series
 - 2. Curriculum issues
 - 3. Freedom of expression/academic freedom discussion
- Retention and recruitment at the university
 - 1. Created hardcopy materials for this purpose
 - 2. Gave guidelines for what search committees can say to candidates
- Lots of thank yous from reps for the work the task force/working groups have done and some suggestions for how to keep the website in people's minds.

formed to help improve how SAC organizes itself and to make the meetings more
effective. He suggested that the new committee would collect ideas and come
up with recommendations to submit to the general council. The council reps
