

SOCIAL JUSTICE FELLOWSHIPS FOR GRADUATE STUDENTS Call for Proposals - 2018-2019 Fellowships

The Social Justice Institute is currently accepting applications from graduate students for an exciting fellowship opportunity to support work in the 2018-2019 academic year. Graduate students seeking funding to support an MA Thesis or PHD Dissertation research are especially encouraged to apply.

Applicants should submit proposals to carry out research or implement projects related to social justice in any discipline. Social justice is defined as eradicating systems of power and oppression with the purpose of advancing fairness and equality through the redistribution of resources and opportunities and exalting human dignity and respect.

A complete application must include the following:

- > A proposal of **no more than three single-spaced pages** in length that includes:
 - A description of the proposed research or project
 - A detailed budget explaining how the requested fellowship funds will be used (requests are permitted up to \$3,500 maximum)
 - An explanation of the connection between social justice and the proposed work
 - The aim and expected outcomes of the research or project
 - A listing of all other people and entities with whom the student will be collaborating, e.g. organizations where research will be done
 - A timeline for the completion of the proposed research or project
- An explanation of **no more than 250 words** in length of how the fellowship will advance the student's career goals as they relate to social justice
- The names of one or more CWRU faculty members who might be suitable to serve as an active advisor for the research or project. (Potential advisors can be contacted at a later date if the applicant is awarded a fellowship. The advisor will guide the student's research and write both mid-year and final reports concerning the student's progress.)
- > A résumé or CV
- An unofficial CWRU transcript

Individuals awarded a fellowship will be required to:

- Complete the proposed research study or project
- Provide a written progress report to the Social Justice Institute at the midpoint and at the conclusion of the fellowship
- Maintain receipts and appropriate back-up for all expenditures and follow CWRU processes for financial reconciliation
- Ensure that the faculty advisor provides separate mid-year and final reports focused on student progress
- Deliver a presentation to members of the Social Justice Institute and invitees at the conclusion of the fellowship

Award guidelines:

Up to a total of two awards (\$3,500 maximum) will be made to graduate students to be used for expenses associated with the research or project. Examples of allowable expenses include:

- Airfare to the site of the research
- Housing costs at the site of the research
- Program supplies for projects
- Stipends to be paid to research participants/interviewees
- Printing costs for study-related materials
- Data sets

Fellowship funds may not be used to fund costs already incurred prior to the date of the award or for research that has already been completed.

Required acknowledgement:

The applicant agrees to acknowledge the Social Justice Institute on all relevant presentations and publications. For example: *This publication was made possible through funding provided by the Social Justice Institute of Case Western Reserve University. Its contents are solely the responsibility of the authors and do not necessarily represent the official views of the Social Justice Institute or Case Western Reserve University.*

Submission and Questions:
