Transformation in Cleveland's Buckeye-Woodhill

neighborhood: Cleveland is one of five communities to receive a combined \$160 million from the U.S. Department of Housing and Urban Development to redevelop severely distressed housing and spur comprehensive revitalization under the federal Choice Neighborhoods Initiative (CNI). Cuyahoga Metropolitan Housing Authority (CMHA) and City of Cleveland were awarded a \$35 million CNI grant for the Buckeye-Woodhill neighborhood. The NIMC team has supported CMHA in the planning process since 2017 and Assistant Director, Debbie Wilber led the successful application process. *Read more about the experience here.*
