Since 1992, I have provided consultation and training to police and probation departments, school security and correctional/residential facilities to enhance services, programs and job-related skills. My areas of focus have been the effects of violence exposure on citizens and officers, as well as best practices in providing positive interactions with and services to youths and their families. Below are selected examples of previous work:

- Trained Cleveland Division of Police officers to interact with residents to establish a 24-hour presence in high-crime areas through occupying former crack houses seized through court orders (Project RAP).
