BW/CWRU – PUPIL SERVICES LICENSE IN SCHOOL SOCIAL WORK

Baldwin Wallace participates in a cooperative program for graduate students enrolled at the Case Western Reserve University Mandel School of Applied Social Sciences (Mandel). The school social work program will meet your requirements to be eligible to apply for a Pupil Services License in School Social work license through the State of Ohio Department of Education.

Graduate Education courses are taken at Baldwin Wallace and the Mandel School to complete requirements for the eligibility to apply for the school social work license.

Students enroll in the following three graduate education courses at Baldwin Wallace:

EDU-510 Educational Studies- (3 credit hours)
EDU-584 Pupil Services and Community Resources (3 credit hours)
EDU-573 Education of Children with Special Needs (3 credit hours)

Billing

Baldwin Wallace tuition is **not** billed through Case Western Reserve University; **you are responsible for paying them directly**. Financial aid can cover your cost of attendance and books and supplies for that semester, and living expenses when attending the summer semester, but those funds are not available until our summer loan disbursement date which is **7/10/2023**

MAEd graduate course tuition at Baldwin Wallace is \$550/credit hour. 9 credits will cost \$4,950.
