Curriculum/ Course Development

Curriculum Leadership (2017 to present) working with a team of faculty, I have led and collaborated with a team of faculty on the transformation of the generalist social work curriculum at the Mandel School. In one semester, the new generalist curriculum integrates theory, practice, and research across micromacro practice, and across courses, weaving anti-oppression, diversity, equity, and inclusion content throughout, and using an active learning model to enhance student understanding and skill development. By providing this content in one semester students are afforded the opportunity to develop generalist-level competencies, allowing them three additional semesters of course work to develop specialized areas of expertise. An innovative feature of the new curriculum is the first week Change Agent Intensive (CHAI) course where students with a wide range of experiences, develop a shared understanding of the history of social work, values and ethics of the profession, and foundational theories and orienting frameworks. This foundation is further developed and built upon in their specialized coursework.
