ONE TO ONE FITNESS DROP-IN CHILD CARE

Offers appointment-based, drop-in child care solution for students, post docs, faculty, and staff of CWRU. Open weekdays 8am to 5pm to any child fully potty trained. Located at 2130 Adelbert Road on the second level of the facility. Reservations are required in advance and made through our MINDBODY software system. Costs \$4 per hour for CWRU students.



SWEET KIDDLES CHILD CARE

Graduate and professional students at CWRU can enroll their children at Sweet Kiddles Flexible Childcare Centers. Children may be enrolled at any Sweet Kiddles center in Northeast Ohio. The closest site to campus is within the Centric Apartments complex adjacent to Uptown and the Cleveland Institute of Art. Can also provide a crib, diapers, clothing, and baby hygiene items if available. To qualify for Mom & Babies Program, you need to be 32 weeks pregnant or your baby must be under 2 years old. The Rainbow Injury Prevention Center is able to assist low income families by providing car seats at a cost significantly discounted from retail prices, together with education in installing and using the seats. JOBS AND FAMILY SERVICES - PREVENTION, RETENTION, AND CONTINGENCY

The Prevention, Retention, and Contingency Program is a critical tool to encourage families to attain and retain employment, prevent dependency, and promote family stability within the context of community priorities and needs. The PRC Program provides nonrecurring, short-term, crisis-oriented benefits, and ongoing services. PRC benefits and services are available to pregnant women and families with children under the age of 18. Applicants must be residents of Cuyahoga County and the total household income must be at or below 200% of the federal poverty guidelines. PRC makes it possible to meet the needs of low-income families through supportive services and/or short-term cash-related payments. Complete the Prevention, Retention, and Contingency Program Application here. Applicants are required to verify proof of income, minor children, and residency. CUYAHOGA COUNTY BOARD OF HEALTH - BACK TO SCHOOL IMMUNIZATION CLINIC

Kids and teens may need certain immunizations before going back to school in the fall. Call 216.201.2041 to make an appointment. Immunization clinic hours are Monday, Wednesday, and Thursday from 9am to 4pm. Some children may be eligible for low or no cost vaccines if the child is uninsured, underinsured, or on Medicaid.

IOB AND FAMILY SERVICES - CHILD CARE SUBSIDIES

Ohio receives funds from the federal government for a state-run childcare subsidy program. These programs help low-income families pay for childcare so they can work or attend school. Applicant must be employed, attending an accredited school, or completing a WEP assignment through the OWF Cash or Food Assistance Program. Household gross income must be under the 130% Federal Poverty Limit (gross income of 130% of the federal poverty level). Can take up to 30 days to be processed. WOMEN, INFANT, AND CHILDREN (WIC) ASSISTANCE

WIC provides nutrition education, breastfeeding education and support; supplemental, highly nutritious foods such as cereal, eggs, milk, whole grain foods, fruits and vegetables, and iron-fortified infant formula; and referral to prenatal and pediatric health care and other maternal and child health and human service programs. TANF - TEMPORARY ASSISTANCE TO NEEDY FAMILIES

Eligibility

Those Eligible:

- Only households with minor children (under 18 years of age) or women in their third trimester are eligible for TANF.
- Children must reside with a parent, specified relative, or legal guardian/custodian.
- Unmarried minor parents and pregnant minors must also be in approved adultsupervised living situations.
- Adults and minor heads of household must participate in work activities.
- Adults and minor heads of households who apply for or receive benefits must sign a self-sufficiency contract.

Not Eligible:

- Adults with no minor children in the home or not in 3rd trimester of pregnancy.
- Individuals who do not sign the self-sufficiency contract.
- Household income exceeds grant amount for assistance group.
- Individuals receiving: SSI income, adoption assistance, foster care payments.
- Individual is a fugitive or parole violator.
- Individual is convicted in a court of law of a fraudulent misstatement of residence.

Work Activity Requirements

All Adult and Minor Head of Household recipients who do not meet an exemption are required to participate in the Work Program. This program provides education, training, and work experience or subsidized employment for required eligible recipients. Comprehensive Case Management and Employment Program for those 24 and younger seeking TANF benefits. Employment assistance – resume building and updating, interview skills, and SNAP nutrition classes, etc.

How to Apply

Only eligible to receive TANF benefits in Ohio for 36 months in a lifetime. Months received as a minor child are not countable towards 36-month time limits. Spouses assume each other's time limits and the higher of the 2 is used for the assistance group. All months received as an adult in a state outside of Ohio are countable towards Ohio's 36-month time limit. All applications are to be processed within 30 days from the date the agency receives the application. Paper and electronic applications are screened, and appointments are scheduled for TANF.
