A law firm within the law school at CWRU. Staffed by students and faculty. Includes ongoing representation of organizations, civil, criminal and administrative appeals, consumer disputes, disability rights, fraud claims, emergency commitment and competency hearings, patentability and patent applications, trademark and copyright issues, misdemeanor and felony cases in adult and juvenile court, defamation cases, and application for relief from deportation. The main clinics include: Appellate Litigation Clinic, Community Development Clinic, Criminal Justice Clinic, Environmental Law Clinic, First Amendment Clinic, Health Law Clinic, Human Trafficking Law Clinic, Immigration Clinic, Intellectual Property Venture Clinic, and Second Chance Reentry Clinic. Legal Aid provides legal services at no cost to clients with low income. Legal Aid handles cases that impact basic needs such as health, shelter and safety, economics and education, and access to justice. Our attorneys practice in areas of consumer rights, domestic violence, education, employment, family law, health, housing, foreclosure, immigration, public benefits, utilities, and tax. CLEVELAND CATHOLIC CHARITIES - IMMIGRATION

Provides affordable legal counseling and representation in a wide range of immigration matters. Services can be provided in a variety of languages. Some of the services that are provided include immigration consultation services, family-based petitions, citizenship/naturalization applications, applications to adjust status/permanent residency, work authorization, protection-based claims, visas for victims, DACA, immigrant visa processing/consular processing, inadmissibility waiver applications, temporary protected status, and immigration court representation. Clients are charged nominal service fees. The **Dean of Students Office**

FAIR HOUSING CENTER FOR RIGHTS AND RESEARCH
