

SECURE HOUSING RESOURCES

ON-CAMPUS SUPPORT

STUDENT EMERGENCY FUND

Available to assist CWRU students who encounter an unforeseen financial emergency or event which would otherwise prevent them from continuing their education at CWRU. OFFICE OF UNIVERSITY HOUSING - OFF CAMPUS HOUSING COORDINATOR

MAINTAINING OFF-CAMPUS HOUSING SUPPORT

CHN HOUSING PARTNERS

CHN Housing Partners housing the Family Stability Initiative and Housing Navigation programs. Family Stability Initiative provides financial assistance and counseling to families with school-aged children in Cuyahoga County who are struggling with housing expenses. This program is available to both renters and homeowners in Cuyahoga County. Contact 216.881.8443 or go to the CHN Housing Partners website for more information. The Housing Navigation program is for eligible households to receive assistance in locating a new home in the city of Cleveland. PREVENTION, RETENTION, AND CONTINGENCY (PRC) PROGRAM

The PRC provides aid and services due to unexpected emergencies. Eligible recipients must be a U.S. citizen or qualified alien, living with at least one minor child, pregnancy, or are the non-custodial parent of a child. The family's income must be at or below 200% of the Federal Poverty Level. To apply and learn more, complete the Prevention, Retention, and Contingency Program application.

HOMELESSNESS OFF-CAMPUS SUPPORT

COORDINATED INTAKE

If you need shelter tonight, call 216.674.6700. Your call can take around 20-45 minutes to gather the required information. Hours of operation are 8:00am to 8:00pm Monday to Friday. If you require shelter after 8:00pm or on weekends, call 211. Coordinated intake can provide exploration of alternative to shelter or shelter diversion, referral for emergency shelter, or referral for emergency services.

CHICO RANCHERIA HOUSING CORPORATION

Chico Rancheria has move in assistance and a low-income rental program. The move in assistance program provides move-in assistance consisting of first month's rent and security deposit. This program can be utilized twice in a lifetime with a four year period between the first usage and the last usage. The low-income rental program provides participants with affordable housing in Tribally-owned units. Apply for the Chico Rancheria Housing Corporation rental assistance program here.



FAMILY PROMISE OF GREATER CLEVELAND

The Temporary Housing program provides rent-free apartments and community living where families stay temporarily while they participate in life skills training, job training, and children's programming to prepare them for stable living in the community. GOVERNMENT ASSISTANCE PROGRAMS

CUYAHOGA METROPOLITAN HOUSING AUTHORITY (CMHA)

CMHA provides affordable housing opportunities throughout Cuyahoga County. This includes the Housing Choice Voucher (receive a rent subsidy to any unit in the private housing market that accepts Section 8 vouchers) and HUD-subsidized housing (properties owned and managed by CMHA). Students at institutions of higher education who do not reside with their parents must meet additional eligibility criteria. These rules apply regardless of whether the student is considered a full-time or part-time student. Assistance shall only be provided to students who are otherwise eligible for the program and meet at

HOUSING TENANTS RIGHTS

LEGAL AID SOCIETY OF CLEVELAND

Legal Aid provides legal services at no cost to clients with low income. Legal Aid secures the justice, equity, and access to opportunity for and with people who have low incomes through passionate legal representation and advocacy for systemic change. Start the process by applying for <u>Legal Aid's help here</u>. The Legal Aid Society of Cleveland also staffs the Tenant Information Line for rental housing questions. CLEVELAND HOUSING COURT CLINICS



Cleveland Housing Court provides residents with a one-stop shop to ask experts landlord-tenant rights, housing and building code enforcement, public health code enforcement, virtual courtroom access, and lead safety questions.
