GOVERNMENT ASSISTANCE PROGRAMS

SUPPLEMENTAL SECURITY INCOME (SSI) AND SOCIAL SECURITY DISABILITY (SSD)

SSI gives cash benefits to people with disabilities who have low income and low resources. You do not need to have worked in the past to get SSI. SSDI gives cash benefits to people with disabilities who qualify because they used to work or have a parent who worked. Some people qualify for both programs at the same time. You must have a medical condition that is expected to last at least 1 year or result in death or prevents you from doing substantial gainful activity (the monthly substantial gainful activity for 2025 is

EDUCATION AND TRAINING VOUCHER

The Ohio Education and Training Voucher (ETV) Program is a federally-funded, state-administered program that provides financial, academic, and human support for young adults who've left the foster care system and are enrolled in qualified colleges, universities, or vocational education programs. For academic year 2025-2026, open date for applications are April 1, 2025. For academic year 2026-2027, open date for applications are April 1, 2026. The Ohio ETV program is open to any former and current young person in foster care who meets at least one of these criteria: foster care will end on and after your 18th birthday; in foster care at age 17 and not enrolled in high school, but have earned a GED or vocational certificate and will remain in foster care until you turn 18; completed state requirements and have a high school diploma, and will remain in foster care until you turn 18; or left foster care after your 16th birthday because you were adopted or placed in a kinship guardianship. Additionally, you must be a U.S. citizen or qualified non-citizen, have personal assets worth less than \$10,000, be enrolled in a degree/certificate/accredited program and show that you are making satisfactory academic progress. Ohio ETV recipients must maintain a minimum 2.0 GPA each term. Students must submit an academic transcript showing grades and GPA from the most recently completed semester/term.
