CLEVELAND CATHOLIC CHARITIES - IMMIGRATION

Provides affordable legal counseling and representation in a wide range of immigration matters. Services can be provided in a variety of languages. Services include immigration consultation services, family-based petitions, citizenship/naturalization applications, applications to adjust status/permanent residency, work authorization, protection-based claims, visas for victims, DACA, immigrant visa processing/consular processing, inadmissibility waiver applications, temporary protected status, and immigration court representation. Clients are charged nominal service fees, which may be reduced or waived according to financial need. The initial consultation fee is \$40. Appointments are required for all locations. CLEVELAND HOMELESS LEGAL ASSISTANCE PROGRAM

Provides pro-bono legal assistance for those experiencing or at risk of experiencing homelessness. Volunteer attorneys often provide advice on issues regarding credit problems, criminal record expungement, driver's license reinstatement, family issues, and landlord-tenant issues.
