**Empowering Communities Study** 

### POSITION OBJECTIVE

Working under limited supervision, coordinate a community-level intervention within the Nourishing Neighborhoods Empowering Communities study (i.e., Nourishing Power study), a participatory action research project of the Mary Ann Swetland Center for Environmental Health. The research assistant will be responsible for developing, implementing, training, and disseminating new and innovative research techniques involving a high degree of skill and training in community-engaged environmental health research. The research assistant will work closely with the principal investigator to explore significant developments and strategies to promote authentic community collaboration in the center's efforts focused on research, training, and community engagement with the broader goal of translating findings of the center into policies, practices, and relationships that promote community and population health equity

The research assistant will serve as the Community Engaged Research Specialist providing coordination to two components of the Nourishing Power community-level intervention: (1) the Food Systems Change Fellowship and (2) Nourishing Power Networking. The fellowship is a six-month intervention offered twice over the next two years designed to support change-makers with visions for transforming the food system through community-driven action. Nourishing Power Networking includes quarterly events and related programming designed to spark community ownership of local food systems change. The research assistant will work closely with the evaluation core of the study to ensure rigorous implementation evaluation of these intervention components. The research assistant, in close collaboration with center leadership, will also serve as the coordinator of the center's monthly seminar series designed to showcase the breadth of community-engaged research conducted by the center and its faculty affiliates, community partners, and invited external speakers that addresses the role of structural racism in creating and sustaining environmental health inequities.

## **ESSENTIAL FUNCTIONS**

Carry out complex research assignments of a non-routine nature by coordinating two components
of the Nourishing Power community-level intervention (i.e., Fellowship, Networking) in nine cities in
Cuyahoga County, Ohio. Work with the principal investigator and project partners to develop and
implement intervention logic, intervention curriculum, marketing and outreach for intervention
recruitment and retention, and implementation evaluation. Apply principles of community-engaged
research and adult learning approaches to effectively engage community stakeholders (i.e.,
residents, food retailers, leaders from community organizations, coalitions, and local governments)
in intervention delivery, prioritizing those representing Black, Brown, and Indigenous communities.

- Devise new protocols and techniques for community-engaged research projects involving a high degree of skill and training. Develop standard operating procedures (SOPs) related to implementation of the Nourishing Power community-level intervention (i.e., Fellowship, Networking) to allow for systematic documentation of study implementation and adaptations over time. Ensure SOPs are up to date and train research team members in study procedures and methodology. (20%)
- 3. Evaluate adequacy of techniques and study and test new procedures to translate and disseminate research findings of the Swetland Center and its partners to inform policies, practices, and relationships that promote community and population health equity. Coordinate the center's monthly seminar series applying principles of community-engaged research and adult learning approaches (10 seminars per year). Conduct evaluation and continuous quality improvement projects to expand the reach and impact of the seminar series and the Nourishing Power study. (15%)
- 4. Co-author translation and dissemination products of the Nourishing Power study, such as data briefs, intervention toolkits, peer-reviewed publications, conference presentations, social media posts, and/or white papers. Provide input and recommendations to the principal investigator to support grant writing related to community-engaged environmental health research. (6%)

## NONESSENTIAL FUNCTIONS

- 1. Monitor the Fellowship and Networking core budgets. (<2%)
- 2. Train undergraduate and graduate students on the implementation techniques of the Fellowship and Networking components of the community intervention. (<3%)
- 3. Perform other duties as assigned. (<1%)
