A Message from Swetland Center's
Pre-Doctoral Fellow, Gwendolyn Donley, M.S.

Swetland Center Response to COVID-19

The world changed in spring 2020 when COVID-19 was declared a global pandemic. This had an impact on every facet of our life including how we work and carry out daily activities such as grocery shopping, schooling, going to the doctor, and day-to-day interactions. COVID-19 laid bare deeply rooted environmental injustices and reinforced the need for environmental supports such as access to parks and greenspace, clean air, grocery stores, and safe child care. In response, the Swetland Center expanded its efforts to include a new focus on COVID-19. Our emerging work aims to bring the lens of environmental health equity to research, policy, and practice designed to reduce the spread of COVID-19 and lessen its impact on children, families, and communities. Our COVID-19 response is currently supported by generous sponsors including the Foundation for Food and Agriculture Research, Ohio Bureau of Workers' Compensation, and the Sears-Swetland Family Foundation.

Ohio COVID-19 Childcare Study Led by CWRU Researchers

Launched in July 2020, the Ohio [COVID-19 Child Care Study](#) is designed to better understand how to lower the spread of COVID-19 and lessen the impact of COVID-19 among families and staff affiliated with child care programs in the state. Led by Swetland Center Director, Dr. Darcy Freedman, the multidisciplinary study team includes investigators from Case Western Reserve University who have expertise in child health and well-being, environmental health, epidemiology, and infectious disease management and control. The study draws on strong infrastructure including the [CWRU COVID-19 Taskforce](#), [Mary Ann Swetland Center for Environmental Health](#), [Schubert Center for Child Studies](#), and the [CWRU Center for AIDS Research](#). foodNEST 2.0 Study Receives Foundation for Food and Agriculture Research (FFAR) Supplemental Grant

The statement released by FFAR states "the coronavirus (COVID-19) pandemic is highlighting food system deficiencies. While the food system is successfully providing for Americans during this crisis, many are encountering empty grocery shelves. Simultaneously, producers are struggling to reach consumers due to concerns with processing, distribution and demand. To understand and address these challenges, the Foundation for Food and Agriculture Research (FFAR) is expanding existing grants to Feeding America and five Tipping Points Program awardees." The supplemental funding awarded to Dr. Darcy Freedman and team will extend their work in developing participatory system dynamic models and allow exploration to better understand how a common system shock like COVID-19 will produce differential impacts at the neighborhood level, given unique starting points. The team will model the effects of COVID-19 in neighborhoods with high, medium and low food security before March 2020. Their findings will be used to tailor food system solutions to diverse neighborhood contexts.
