## Information for January (Fall 2017) Degree Candidates

Planning on a fall 2017 graduation? Please double check your Academic Requirements Report and make sure everything is "Satisfied."

**Repeating a class for which you already have credit?** Make sure you will have earned enough hours to graduate. When you repeat a class, the hours for both courses appear in your total hours until course repeats are processed after grades are posted. Once the repeat process is run and the first iteration of the course is no longer bearing credit, your total hours will decrease. Make sure you have sufficient hours once that credit is removed.

Reasons your AR report may not indicate everything is "Satisfied" include:

1. **Missing writing portfolio.** Information on what you need to do to hand in your portfolio can be found [here](#).
2. **You have a class exception or substitution** and you are currently in that class. The exception will not appear in SIS until you have a final grade in the class. If you have not already done so, you must submit an [Advisement Report correction form](#) for a substitution.

Applying for graduation should take no more than five minutes. However, it is an important process as it allows you to indicate how you want your name to appear on your diploma and to confirm the degree(s) you will be earning. You will see the "Apply for Graduation" option in the academic drop-down box in [SIS](#). The deadline to apply for graduation (via SIS) is Oct. 1.

Even if your AR report is not "all satisfied" you can and should apply for graduation. Once your application is in, we can work on making sure all requirements are met.

If your plans have changed and you are no longer planning to graduate in January, contact the Office of Undergraduate Studies so your SIS record can be updated to ensure that you will be able to register for spring 2018.

## Important Policy Changes for 2017-2018

On the recommendation of the Faculty Senate Committee on Undergraduate Education, the Faculty Senate adopted three new procedures that will affect undergraduates beginning this fall.

1. **Students who do a complete withdrawal from all of their courses late in the semester.** Students who do a complete withdrawal after the 11th Friday of a semester (corresponding to the deadline for individual course withdrawals and opting for P/NP grading) may not enroll for the next two academic sessions, with the summer session being one of those two. Exceptions may be granted by the Academic Standing Board.

*This policy was adopted based on review of the academic performance of students who return quickly after having done a complete withdrawal. It is understood that some of the reasons that students choose a complete withdrawal may be resolved quickly, so the new policy leaves open the possibility of granting exceptions in individual cases.*

2. **Students placed on probation and continuing for the next semester.** Students placed or continued on probation are required to review their course schedules with their Undergraduate Studies deans before the end of the drop/add period in order to continue for the next semester.

*The goal of this policy is to help students design a schedule for the next semester that will promote their success, after having chosen courses before the outcomes of the previous semester are known. Consideration was given to setting a credit-hour limit for students on probation, but it was determined that more nuance is necessary, as the issue for a student may not be the overall number of credit-hours (though it may be) but rather the specific choice of courses (such as continuing in a course sequence with a D in the prerequisite course).*

3. **Transcript notations for students on probation.** Beginning with Fall 2017 semester, academic probation will be a status recorded on the unofficial/advising transcript but not on the official University transcript.

*Currently academic probation is noted on both the unofficial and official transcripts. Because academic probation is an automatic action and the raw data that triggers this action (grades and credit-hours earned) are already recorded on the official transcript, it was determined that there is no reason to record academic probation on the official transcript. All past academic probations will remain on official transcripts, but no new probations will be recorded going forward.*

## Sept. 8 is the Drop/Add Deadline

Friday, Sept. 8 is the deadline to drop or add a full-semester course. You may continue to make schedule adjustments in SIS until 11:59 p.m. Friday. However, staff will not be available in the University Registrar's Office or the Office of Undergraduate Studies to assist you, so you may be stuck if you wait until after 5 p.m. The last day to drop or add a second-half course (e.g. physical education) is Tuesday, Oct. 31.

Things to review:

1. Verify that you are registered for all the classes you think you are in. Make any drop/add changes.
2. Make sure you are registered for the right section number when there are multiple sections.
3. If you are on a waitlist or waiting for permission for a class, all changes must be completed by 11:59 p.m. Sept. 8. Remember: Once you receive permission for a class, you must still register. In most cases, once you have been granted permission, you can register in SIS. The exception is registration after being granted time conflict permission, which requires you to follow the instructions on the permission approval email or a visit to the University Registrar (Yost 135) by Sept. 8.
4. Make sure to register for physical education (including varsity sports) and music ensemble classes.
5. Verify the number of credit-hours you are in for courses that have variable hours (including independent study and music ensembles).

## Nov. 10 is the Class Withdrawal Deadline

After Sept. 8, the last day to withdraw from a class is Friday, Nov. 10. You can withdraw from a class through SIS if you are in good academic standing and will not fall below 12 hours by withdrawing from a class. To withdraw from a class in SIS, go to the "other academic" drop-down menu from your student page and select "Enrollment: drop." This is the same process that you use for drop/add, but you will receive a message reminding you that you will receive a "W" grade.

Although you may continue to withdraw from classes in SIS until 11:59 p.m., Friday, Nov. 10, there is no reason to wait until the deadline. However, staff will not be available in the University Registrar's Office or the Office of Undergraduate Studies to assist you after 5 p.m.

If you are not in good standing, will fall below 12 hours if you withdraw from a course, or want to talk to someone in the Office of Undergraduate Studies before withdrawing from a class, please stop by Sears Building 357. You can find your dean's walk-in hours [here](#), or you can call 216.368.2928 to make an appointment.



## Nov. 10 is the Pass/No Pass Deadline

If you plan to use the pass/no pass option for a class this semester, you must complete the P/NP ballot in SIS. To select P/NP, go to the "other academic" drop-down menu from your student page and select "Pass/No Pass Request." The deadline to apply for the P/NP option is Friday, Nov. 11, at 11:59 p.m.

You may use P/NP for only one class other than those regularly graded P/NP, and you must remain enrolled in at least three semester hours for an evaluative grade. If it is a course required for your major, minor, or SAGES requirement, you can use the P/NP option, but you will not be able to use that class to fulfill the requirement. You will need to take the class again for an evaluative grade or another applicable class to fulfill the requirement.

Students in a Weatherhead School of Management major (accounting or management) may not use the P/NP option for any Weatherhead courses (ACCT, BAFI, BLAW, ENTP, LHRP, MGMT, MIDS, MKMR, OPMT, ORBH, OPRE, PLCY), either required or elective.

## What Does "REQ TERM" on Your Academic Requirements Report Mean?

Have you noticed the "REQ TERM" notation at the top of your academic requirements report in SIS? Do you know what it means? Departments periodically update the requirements for their majors and minors. In addition, the schools occasionally make modifications to their general education requirements. The req term on your AR report tells you the set of requirements you need to meet to complete your degree. Your degree requirements are those that were in place at the time you matriculated at CWRU, so the req term is set for the fall term of the year you entered CWRU. Even if you matriculated as a transfer student in the spring semester, it is coded as the fall of that academic year because we update degree requirements once a year.

When a program changes its requirements, they are coded in SIS with a new req term and are binding on students who matriculate the following August or later. If you find that requirements have changed in a way that is favorable to you since you matriculated, you can have your req term updated. If you have questions about your AR report or you wish to update the req term, see your dean in Undergraduate Studies.

## Final Exams – Verify Your Schedule Now

*You must be here for your final exams, so plan your travel schedule accordingly. You are able to see your final exam schedule in SIS. The last day of final exams is **Wednesday, Dec. 20**.*

*No student is expected to take more than two final exams on the same day. Also, no student is expected to take an evening exam in the 7:30 – 10:30 p.m. slot and another exam the next morning in the 8 – 11 a.m. slot. Dean Wolcowitz will reach out to students who fall into these categories or who have two final exams scheduled for the same time after the course withdrawal deadline (Nov. 10) to make alternative arrangements. A faculty member may not change the date of a final exam for a class or an individual student.*

## CAS BA Students: Are You Aware of the 42-hour Rule?

*The BA is designed to provide you with a breadth of academic experiences. For this reason, the College of Arts and Sciences has the “42-hour” rule for BA candidates: No more than 42 credit-hours beyond the 100-level in any one department may be applied to the 120 credit-hour total.*

*If you have any questions about the rule, be sure to discuss it with your academic advisor or [dean](#) in Undergraduate Studies.*

## Academic Standing Regulations

*The Academic Standing Board monitors the progress of all undergraduate students at the end of each semester to ensure they are making appropriate progress toward earning their degrees in terms of the grades and number of credit-hours earned each semester.*

*All undergraduates begin their academic careers in good standing. Those who fail to meet the requirements to maintain good academic standing are subject to review by the Academic Standing Board. For more information about the academic standing regulations, click [here](#).*

*Final grades for the fall 2017 semester are due Friday, Dec. 22. Please check your grades so you are aware of your academic standing. Students that are not in good academic standing based on their fall 2017 grades should expect to hear from their upperclass deans by Tuesday, Jan. 2, 2018.*

## Scholarship Retention Criteria

*Students who are awarded scholarships based on academic achievement or potential by Case Western Reserve are expected to perform at an appropriate academic level and maintain good conduct in the community. These scholarships will be automatically renewed each semester, provided the student meets the retention criteria established for his or her scholarship at the time of the initial award. *Students in jeopardy of losing their scholarships based on fall 2017 grades should expect to hear from their upperclass deans by Tuesday, Jan. 2, 2018.*

MMI is a popular approach to interviewing used by a growing number of professional health science programs. Participating pre-professional students will rotate through five different prompts (interviewers) and a feedback session within a one-hour time block. Students applying in the current application cycle (2018) interested in practicing their interviewing skills in the multi-mini interview format may participate.

Students can sign up for an MMI time slot through Handshake. If you have not activated your Handshake account, go to [case.joinhandshake.com](http://case.joinhandshake.com).

If you have already activated your account, log in to Handshake at [MyCareer](http://MyCareer). Once you have logged in:

1. Click the "Jobs" link at the top row of the page.
2. Click "On-campus Interviews" located in the blue bar in the top right corner of the page.
3. Using the search box to the left at the top of the navigation menu, search for "Case Western Reserve University - MMI Mock Interview Day." If you type "MMI" that should bring it up. Click that link.
4. In a blue bar in the middle of the page, you will see the message, "To apply to this interview schedule you must qualify and apply through one of the associated jobs." Look down the page and you will see a position called "MMI Mock Interview Day". Click that link.
5. Toward the center right, click the green "Apply Now" button. A window will pop up. You can disregard the questions about document because you don't need one to apply. Just click the "Apply" button.
6. You will see a message in a blue box that says, "You qualify for this schedule and can take a slot. Below that are the available time slots." Find the time slot you want and next to it, click the green button "Take Slot."
7. If you change your mind and there are other time slots available, click the blue "Switch to Slot" button.
8. If you click the "Leave Slot" button, that means you are giving up your slot without selecting another one.

Be sure to state in your message your graduation date and confirm that you applied to health care professional schools this cycle. 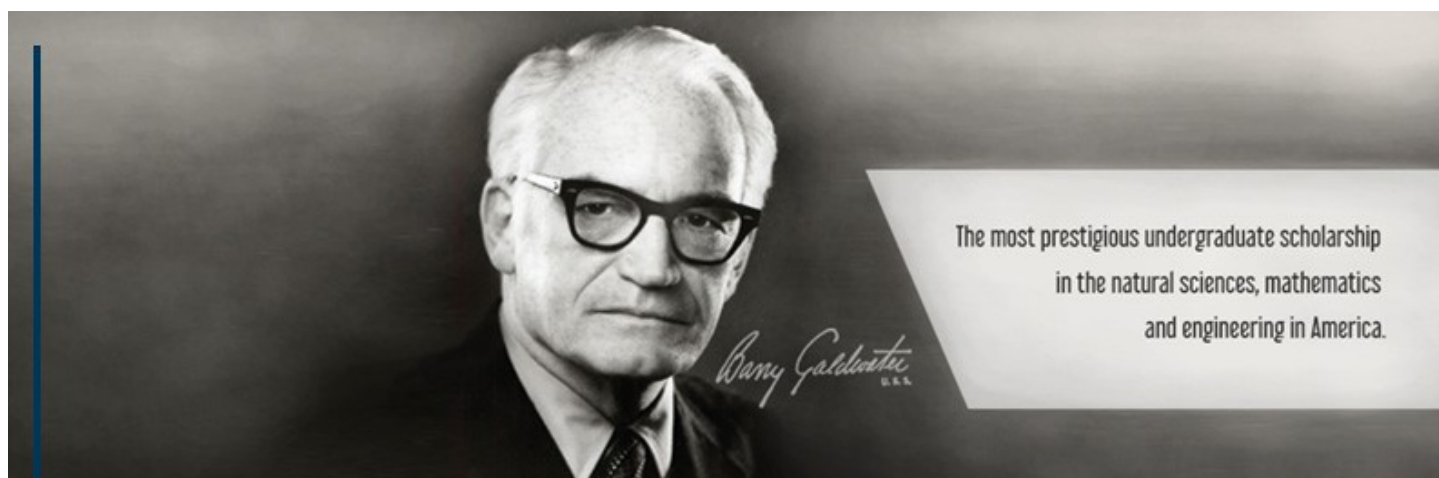
