#### **Required Fees for Nonimmigrant Visa Petitions Filed on Form I-129:**

**H-1B:**    \$460 filing fee- *required for all H1Bs*  
           \$500 fraud prevention fee *-only required if this is the first H-1B filed by CWRU for this employee.*

**O-1:**    \$530 filing fee

**TN:**    \$510 filing fee

**E-3:**    \$510 filing fee

**Optional fees (must be paid using a separate USCIS Credit Card Authorization Form):**

\$2,805 (Premium Processing fee -- requests adjudication within 15 business days)

**\*NOTE – fee will increase to \$2,965 effective March 1, 2026.**

**Dependent fees (employee must pay with personal credit card and use a separate USCIS Credit Card form for each application being filed):**

\$470 (I-539, Application to Extend/Change Nonimmigrant Status)
